## About the Award

The NCIS Board of Directors directed NCIS to formally recognize an individual, or individuals who is/are who are currently serving or have served (retired) in leadership capacities within the industry who exhibit(ed) outstanding leadership, guidance and knowledge to and of the crop insurance industry.

## Objective

The Lifetime Achievement Award is designed to recognize outstanding leadership on behalf of the entire crop insurance industry of an individual or individuals who consistently demonstrate(d) outstanding leadership, guidance and knowledge to and of the crop insurance industry.

## Eligibility

- Current or retired members of the crop insurance industry who are currently working or have worked for a crop insurance company.
- They must exhibit strong personal and business ethics.
- They must demonstrate effectiveness in service to the crop insurance industry.
- They must represent themselves, their company, and the crop insurance industry well.

## How to Enter

To enter, follow these steps:

1. Select a nominee(s) This nominee(s) should exemplify the qualities of a true leader. Consult the eligibility requirements closely.
2. Fill out the application on the back of this page and then address the three questions on a separate sheet(s) of paper. Include your contact information. If NCIS has questions regarding the application, the nominator will be contacted. All nominations will be kept confidential.
3. Send application and narrative to NCIS by October 15, 2017.

## Nomination

All nominations will be considered. The NCIS Communications & Outreach Committee will review all submissions and make a formal recommendation for selection of this award to the NCIS Board of Directors.

The award will be presented to the winner at the 2018 Crop Insurance Industry Annual Convention.
