Data Mining Steering Committee Meeting

Approved Insurance Providers (AIPs), NCIS and RMA members of the Data Mining Steering Committee participated in a meeting with the staff from the Center for Agribusiness Excellence (CAE) of Tarleton State University, held in Stephenville, Texas this past week. CAE operates RMA's data mining initiatives. Data mining incorporates the latest advances in database technology into a single, centralized "data warehouse" of all the crop insurance-related data in RMA databases, and allows it to be compared to FSA acreage and entity records, as well as weather, soils, flood, hurricane and other spatial data. RMA and industry formed the Data Mining Steering Committee in response to the changes in Appendix IV of the 2011 SRA, which calls for a greater use of data mining to target the quality reviews being conducted by AIPs. CAE demonstrated their latest data analysis techniques, reviewed the data they maintain to support their analysis, and overviewed data mining products they have in development which will facilitate greater cooperation between RMA and the AIPs.

NCIS Presentation at Crop Insurance Professional Association (CIPA) Meeting

NCIS President, Tom Zacharias, participated in a presentation at the Crop Insurance Professional Association (CIPA) meeting Monday, May 7 held in Kansas City. *"CIPA is a national organization of agents – spanning from Florida to California and from North Dakota to Texas – who are committed to maintaining and strengthening the safety net for the American farmer and rancher through a strong Federal Crop Insurance Program."* The NCIS presentation included an industry update, along with a discussion of RMA's actuarial methodology revision, a brief farm bill overview, and highlights from the Senate testimony.
