## **Japanese Delegation Visits NCIS**

Laurence Crane, Mike Sieben, and Frank Schnapp of NCIS met with a two person delegation from the Japanese Ministry of Agriculture and the National Agricultural Insurance Association on December 5<sup>th</sup>. The purpose for the meeting was to discuss the advantages and disadvantages of revenue protection insurance in general and the Adjusted Gross Revenue program in particular as a possible new form of insurance protection for Japanese producers, along with the associated underwriting requirements and loss adjustment process for the program. Rainfall Index coverage for the Pasture, Rangeland and Forage program was a second topic of discussion. The delegation also reviewed the design and operation of the current multi-peril crop insurance and livestock disease and mortality insurance in Japan. The major perils for Japanese producers are cool weather and heavy rains due to the frequent prevalence of typhoons.



## **Program Development Committee Conference Call (PDC)**

The Program Development committee held its quarterly conference call this past week. The PDC committee is comprised of representatives from each of its seven standing committees. Issues and improvements to the crop insurance industry from each of the standing committees are brought to the PDC for approval, which

are then sent to the Board of Directors for final approval. Actions approved at this meeting included tobacco and corn loss instructions and service awards.
