Rural Coalition Winter Forum

NCIS participated in the Rural Coalition's Annual Winter Forum, December 4-5, 2014 in Washington D.C. The Rural Coalition is an alliance of farmers and organizations who support them, working together toward two long-term goals: 1) Development and implementation of progressive policies responsive to rural needs, and 2) Development of the capacities of rural organizations and people to work effectively to sustain institutional and systemic change. Dr. Laurence Crane, NCIS, participated in the discussions and explained the crop insurance industry's proactive outreach activities to reach traditionally underserved audiences. He also discussed how crop insurance can be an effective risk management tool to help farmers remain profitable, and thus benefit the communities in which they live.
