Objective

This training will focus primarily on the completion of paperwork for several different types of farming operations with emphasis on certain aspects of the program including, but not limited to, animal and nursery inventory reports, expected value determinations and documentation, accounts receivable and payable, review of the Farm Operation Report, VIP/Direct Market policies, Expanded Operations, and claims for indemnity.

Material Needed

Participants should bring their laptop, calculator and writing utensils. Policy material, information necessary to complete the examples, and the handbook will also be available through the NCIS FTR school page and **should be downloaded prior to arriving at the training**. The information will be available to current accountholders and new accounts will be set up, as needed. Loss example paperwork will be provided separately.
